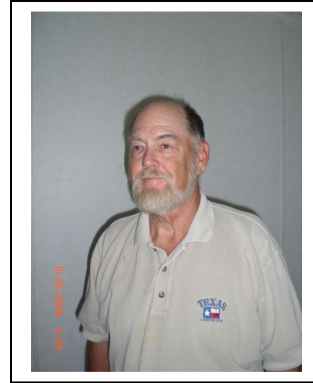


## **A MATTER OF “STANDING”**

**I like many others have been  
Baffled by the continued denial  
Of the United States Courts of  
Any challenges to the candidacy  
Or qualifications of Barack Hussein**

**Obama aka Barack Soetoro aka Barry H. Soetoro aka  
Hussein Soetoro. A substantial research effort was undertaken by multiple groups  
and individuals to reach the truth of this continued program of obvious denial of  
American Constitutional Rights and the requirements of the Constitution itself.  
This is a short summary of the reasons behind the rulings of the Federal  
“US District Courts”, and the crooked interpretations involved.**

**I personally filed a Criminal Complaint on September 2, 2008, with Andrew Bland,  
Agent in Charge, FBI Houston, and Donald I. De Gabrielle, Jr., United States  
Attorney, Houston, Texas with supporting informations of commission of Felony  
Crimes by Barry ( Barack ) Hussein Obama under United States Statutes. Neither  
of these government employees has ever called me, written to me, or acknowledged  
the submission of the Complaint. Both have refused on multiple occasions to speak  
with me on the phone. After many phone calls, I discussed the complaint with  
Susan, the staff person for Donald De Gabrielle, US Attorney, after faxing another  
copy to his office as they seemed unable to find the original, sent Registered, return  
receipt requested. She said I had no “STANDING” to file a complaint, as I had no  
proof that any of the alleged offenses occurred in their Texas district, and there is no  
requirement for the FBI or USDJ to respond to me. Obviously the fix was in.**

**Both of these public servants are prima-facie guilty of Misprision of a Felony 18  
USC section 1, and Obstruction of Justice 18 USC chapter 73. Multiple other  
persons filed criminal complaints, and actual Civil Lawsuits, to force compliance  
with the Federal Law Statutes, the American Constitution, and published election  
laws rules and regulations. ALL the United States Courts kept ruling that no one  
filing these complaints and lawsuits had any standing to do so, and the matter was  
thrown out. So what is the answer to this situation?**

**In a Keep it Simple format.**

**ANSWER 1: There is no united States of America ( died in 1933 )**

**ANSWER 2: “THE UNITED STATES” is a Private Corporation, owned  
By Foreigners, who are the only persons with “standing”.  
It is “Doing Business As” the United States Government.**

- ANSWER 3:** There is no united States of America Constitution ( died in 1933 and buried by the Supreme Court in 1935 )
- ANSWER 4:** “ THE UNITED STATES “ corporation can have any Person of any nationality as President and CEO as elected By the corporation board and owners ( no rules ). As a Crown Offshore chartered trust corporation, owners are secret.
- ANSWER 5:** The phony elections in the United States have all been rigged Since 1913 and controlled by the Banking Cartels who own All property in America, the sale completed in 1933.
- ANSWER 6:** Only the International Uniform Commercial Code ( private Laws ( old Roman Law of Contracts )exists ) For application in Federal US Courts, as they are part of THE UNITED STATES corporation administration.
- ANSWER 7:** Because no one has a Contract with THE UNITED STATES Corporation to determine any person’s fitness to be an Employee of the corporation, no one has any “ standing “. This is the Position of ALL the US Federal Courts.
- ANSWER 8:** Because no “ State “ ( who can go to the US Supreme Court Directly with Civil Action ) has challenged this illegal mess, All of the activities of the “ Government “ which are outside The US Constitution are handled by THE UNITED STATES corporation, which has NO constraints.
- ANSWER 9:** The Federal Reserve, the Internal Revenue Service, the Department of the Treasury, 39 other supposed US Govt. Agencies are in fact privately owned corporations, for Profit, which operate outside State Laws and constraints, Are owned by the Banking Cartel families who are the FED. Look for them in 31 USC code for the Treasury Department Agencies, rules, and regulations. You will not find them.
- ANSWER 10:** No Statute Law, or the Constitution, ever gave the Physical Property of America to the ownership of THE UNITED STATES corporation ( District of Columbia ) , ever gave the Ownership of the Offshore Trust Territories to THE UNITED STATES corporation, and the Constitution does NOT give the central Federal Government authority to sell The Physical Property of America to anyone.
- FINAL ANSWER:** Obama is President of THE UNITED STATES corporation But NOT President of the united States of America, which does Not exist anymore. Per the US Federal Courts.

Also prima-facie guilty of the Felony crime Misprision of a Felony 18 USC Section 1, and Obstruction of Justice 18 USC chapter 73, is James Burris, FBI Chief Investigator of Election Fraud, Washington, DC, who has repeatedly refused to do his job after receiving multiple written and thoroughly documented complaints. It is obvious at this point that :

1. Barry ( Barack ) Hussein Soetoro Obama is NOT and never has been an American Citizen. He is a Citizen of Indonesia? Or Kenya? Or the UK?
2. That falsified documents were filed with US Government agencies, violating 18 USC 1018, to obtain a US Passport.
3. That falsified documents were submitted and filed to obtain US Government security clearance, a Felony under 18 USC 1018 and 18 USC section 1.
4. That falsified documents were submitted and filed with the Federal Election Commission to obtain Federal employment, a Felony under 18 USC 1018.
5. Barry ( Barack ) Hussein Soetoro Obama has been Illegally domiciling as an Illegal Alien in the State of Illinois, and the country of America, and filing false information documents to obtain benefits from the State of Illinois, and US Government, and education benefits under falsified documents to private and State owned College Institutions. 18 USC 241, and multiple state laws.
6. A Criminal conspiracy by Barack H. Obama, and multiple persons to commit FRAUD against the Sovereign State of Illinois, and the United States for personal gain and benefits and larceny has been ongoing for years. The vice President is the team leader in this, acting as Agent for the Council on Foreign Relations.
7. Misprision of a Felony and Criminal Conspiracy done by highly-placed co-conspirators within the United States Government ( these are the ones who Federal Laws and Regulations actually apply to ) who have blocked and interfered with background investigations, and civil lawsuits, which would have thru due diligence exposed the truth of the falsified documents. 18 USC chapter 73, 18 USC section 1.
8. The ARMY belongs to the Republic of the united States of America, since Obama is NOT an American Citizen, how can he be Commander in Chief? The Secretary of Defense is obviously part of the Conspiracy.

What to do? The Attorney General is an anti-American, anti-gun communist, he obviously will block any action civil or criminal in the Federal courts system.

The State Courts of each of the Sovereign States have Concurrent Jurisdiction in administration of Justice, and enforcement of laws on interstate and intra-state commission of felonies and criminal conspiracy. These criminals can be indicted by any sovereign State, and must be arrested and extradited to the State Jurisdiction for trial on the criminal charges. This is the same 1935 agreement between all the states the Federal government uses all the time to encroach on states rights to claim the Federal government has concurrent jurisdiction in matters not supported by the American Constitution or treaty. The rules of discovery and investigation require any other State of the Union to co-operate and supply public documents as requested by subpoena. A grand jury in any State can immediately require any documents, without constraint, from any other State, or the Federal Government as part of an on-going criminal investigation. Any interference from any US

Attorneys, or even the US Attorney General can immediately land them in Jail, for contempt of Court, ( Federal Courts cannot interfere with this or overrule the subpoena ), and it is a Felony to use Government money and resources to act as agent for a Private Person to block or interfere with criminal inquiry into their criminal actions. ( misprision of a Felony again ) Any US Attorney who has acted to suppress and block the investigations and civil actions on public money has committed a felony crime ( 18 USC section 1 ).

Go today to your State Court and file your Criminal Complaint, with supporting documents. Plenty of documents are available in Civil Action Case 08-CV-4083 at the US District Court for the Eastern District of Pennsylvania, filed by Phillip J. Berg against Barry ( Barack ) Hussein Obama, citizen of Kenya, illegal immigrant to America, illegal holder of American public office, and communist criminal.

Your local Court will tell you that you have no standing, as you cannot prove you are an injured party. Look up your own state's law covering criminal conspiracy and fraud. These offenses are not constrained by State borders. They must accept criminal charges, as it is not a civil matter, and you are being injured by your tax money being stolen by a usurper and his criminal gang. Find 700 friends and file identical paperwork. Have sit-ins every day at the district attorney's office until they take the complaints before a grand jury. Make it a point that the grand jury issue subpoenas for the required missing documents. Follow up every day. Do not let the matter rest. Make sure that the District Attorney is fully informed that this will be his last term if he fails to take immediate action. He is afraid of the New York bank gangsters. Make him more concerned about his replacement locally, permanently. Make it very clear you will proceed with a Recall Petition ( every state has this Law )to remove him from his office if he fails to do his sworn duty.
