

## **The Day America Was Sold to the Jews**

**On June 5, 1933 the United States Congress sold all of America, lock, stock, and barrel. The Federal Reserve system, a group of 12 Privately owned banks, owned by the trillionaire Jews, almost all Foreigners, owns all property, mountains, national parks, buildings and improvements, farms, rivers, machinery, and rights to grow crops, produce oil, and make products, in every inch of America, public and Private.**

### **You Ask – How is this possible?**

**By the Constitution** of the United States of America, it is not possible. Nowhere in the constitution does it say that the United States Federal Government **OWNS America**, or has the right to **SELL it to foreigners**. But that is exactly what the Federal Reserve Act of 1913 and the Emergency Banking Act of 1933 did. **To finance deficit spending** by the Government ( Congress ) without limits, the Congress took out a **first mortgage** on the country, the terms of which give **unlimited title and rights** to the 12 private Federal Reserve Banks to **all property and assets** of the entire nation and it's people. The few members of congress who objected, and tried to stop this travesty, tried to get the perpetrators impeached. The New Deal ( Communists ) Democrats had a solid majority, and a Democratic President, and the impeachments went nowhere. Both Acts would have to be **Amendments to the Constitution** of the United States of America to be valid.

The terms of the deal are such that the ownership of the Federal Reserve Banks **does not have to be disclosed**, as Offshore Chartered Trusts, the banks are outside Congressional control or oversight, outside any banking regulations control, audit by OMB, or any other scrutiny. The banks are **chartered offshore** as “ Trusts “, and do not have to disclose ownership, earnings, operate tax exempt, collect **interest IN GOLD** on the national debt loans they give to the government, and are allowed to be **totally outside the reach** of the US Congress, OMB regulations, and audit or disclosure requirements, or control of officers or management. The Federal Reserve Board, including it's chairman, serve only to set **policy objectives** for the Prime Rate interest charged for **your money** loaned, and general policy for manipulation of the money supply. The sole function of the Internal Revenue Service, a Private Corporation, also chartered Offshore as a “ Trust “ is to acquire money and funnel it into the Federal Reserve Banks, to pay the Interest on the open-ended loaning of Fiat currency ( our own currency, called Federal Reserve Notes ) loaned back to the Government at interest. **ALL of the Income Tax collected** by the IRS goes for this purpose, not one penny goes to running the Government functions ( US Congressional record ). They ( the Administration ) just print and issue currency as Fiat Money ( called legal tender? ) as they see fit to finance the US Government activities.

When a Government spends more than it takes in, this is called **deficit spending** ( borrowing ). As of Christmas 2006, the actual National Debt has exceeded 51 **Trillion** dollars. This is the total of the actual debt to the Federal Reserve, loan guarantees, promised payments to retirees, promised funding of all the entitlement programs, and the 2.4 Trillion dollars already appropriated from the Social Security “ Fund “ which there is none left. ( Except the 37 Trillion cash in the CIA/NSA hidden offshore accounts ) The value, lock stock and barrel of the United States of America, is only 49 Trillion dollars, at todays inflated values. The Federal Corporation mortgaged the country, kept the cash.

Who are these mega Jew trillionaires? According to **Eustace Mullins** who has researched the matter for many years, and published in her book **Secrets of the Federal Reserve**, they are:

1. the Rothschilds family ( London and Berlin ) ( 168 Banks and Trusts, Europe, Asia )
2. Lazard Brothers Trusts ( Paris ) ( 144 Banks and Trusts in Europe and Mideast )
3. Israel Seiff Trusts (Italy )(68 European Banks, World Bank, Intl Bank of Settlements)
4. Kuhn-Loeb Companies ( Germany ) ( 31 Banks in Germany, Switzerland, Dubai )
5. Warburg Company Trusts( Hamburg, Germany and Amsterdam, Holland )(39 Trusts)
6. Lehman Brothers Trusts ( New York, USA )( Bank of Nova Scotia, 39 more )
7. Goldman Sachs ( New York, USA ) ( Bank of America Group ) ( Citibank Group )
8. Rockefeller Family Trusts ( New York, USA )( Chemical Bank, First Union Bank)
9. J.P. Morgan Trusts (JP Morgan Chase Bank Group, 41 banks ) ( 23 Trust Groups )
10. Greenwood Trust Group ( Discover Card, Sears )(Watchovia Banks Group )
11. The British Royal Family ( London, UK )( Bank of England, 6 more Banks )
12. Thyssenkrupp AG ( Berlin ) ( 19 German Banks ) ( 21 Trust Groups )( Deutchbank )

**Essentially, the United States Government as a Sovereign Entity Was Dissolved in 1933 when the U S Government was declared Bankrupt and Insolvent. The Federal “ United States “ is a corporation “ United States Corporation “ 28 USC 3002 (15)(A) which runs the country’s activities per the Unified Commercial Code.**

**When you went to school, how many of the History books you read told of the day that America went bankrupt, and the US Government sold off the country?**

**Did any of your textbooks on Government, history, economics teach you that you were a bond slave, and you had to work all your life for your Jew Masters?**

**How did this happen?** The Emergency Banking Act, March 9, 1933, 48 Stat 1, Public Law 89-719, as declared by President Franklin Roosevelt, the Federal Government being bankrupt and insolvent. HJR 192, 73<sup>rd</sup> Congress m session June 5, 1933, the joint resolution to Suspend the Gold Standard and Abrogate the Gold Clause. This bankruptcy, and the assignment of the ownership of **all** property of the United States, rights to labor, private property, and the rights of private property were all pledged as collateral to support this deal. They can literally take over at any time.

**This Law is unconstitutional, and to be valid for the United States of America, it would have to have been an Amendment to the Constitution of the United States of America, and approved by the required  $\frac{3}{4}$  plurality of the States.**

As the **Federal Reserve** is outside of Congressional Authority, **it has never been audited** or investigated by congress or any other agency. All 3 of the Senators who wanted to hold investigative hearings died under mysterious circumstances, before they could do anything. To date ( Dec 2006 ) the Federal Reserve Banks have collected 77 Trillion dollars in Gold as interest on the Fiat paper money “ Loaned to the United States “. The holdings collected have seen a 13,000 % increase in appreciated value on their held Gold as the gold price against the dollar has risen since the US Government confiscated it all in 1933. The profit was immediate, as in 1933 when the government seized all Gold coins, at then valuation of \$ 27 per ounce, then 6 months later in 1934, revalued Gold to an official \$ 32 an ounce. Almost no one in America understood that the value of the **US Dollar was devalued** against Gold, which meant the dollar was devalued against all other currencies in the world. This was in the deepest pit of the Depression, and the Government screwed the people out of \$ 26 billion ( in 1933 dollars, equivalent to 9.3 Trillion of 2006 dollars ). All this Gold went immediately into the coffers of the 12 Federal Reserve private banks. Did any of your history books say anything about the **Dollar Devaluation**, where the US Dollar lost 42 % of its value in one day? Gold today trades on the world market at \$ 683 per ounce.

President Franklin D. Roosevelt, and the Democratic Congress moved immediately ( 1933-34 ) to make New Deal public works projects, roads, dams, canals, river projects, port projects, through **Deficit Spending** ( borrowing money from the FED, and Treasury Securities sold thru the Fed ). The stock Market Crash and financial panic was over the year **before** all this, and the Panic had already subsided. The actions to devalue the dollar at this point made no sense. It was a lame excuse for giving away the country, and making a deal for unlimited Federal Spending, a large portion of which went to vest

pocket insiders. Only the deficit massive spending for Defense Projects of World War II ended the Great Depression. The Great Depression itself was contrived and planned by the Mega Jew families, to break the back of the Independent Oil corporations in Oklahoma, Texas, Louisiana, and Kansas who would not sell out to the Mega Jew Trusts. The Mega Jew Trusts bought up the oil, timber, mining, and ranching conglomerates for pennies on the dollar, because **they had the Gold**. In 1965, President Johnson removed Silver from US Coins. In 1978, Congress officially took America off the Gold Standard, and removed **any redemption promise** from the US Currency ( Federal Reserve Notes ) formerly Silver Certificates, so **there is no thing of value backing the Federal Reserve Notes**. All these actions are squarely **against** the United States Constitution.

In Truth, since the Bankruptcy of the Federal Government was declared in 1933, the United States ceased to be a **Constitutional Republic**, with laws based on the Constitution, and instead has operated as a “ **Government Corporation** “ under direction of the President, under the 1914 War Powers Act. The “ Government “ is a **subservient corporate entity** owned by and totally controlled by the Federal Reserve Banks, and their Parent the World Bank, International Monetary Fund ( IMF ) and its Parent entity, the International Bank of Settlements. Continuous “ Crisis “ situations and “ War Actions “ have ensued continuously to assure that the deficit spending continues unabated. The Secretary of the Treasury actually is an employee of and controlled by the World Bank, and its evil mother **The International Bank of Settlements**. All of these banking entities are owned and controlled by the same Mega Jew families. The United States military is the official **enforcement arm** of the international Jew Trillionaire bankers. Military actions are taken by the US Military to retain the status quo of **assets ownership and control** by the Jew Trillionaire families on a world-wide basis. The US sons and daughters are sacrificed to maintain the Mega Jew ownership and control of land, banking, money transfers, and oil interests, all denominated in US FRN’s.

All **Oil Deals** have been denominated in **US Dollars**. Saddam decided to change Iraq oil sales to Euros, and got invaded. Cesar Chaves of Venezuela has now done the same thing, as has Iran. If several more OPEC countries follow suit, there could be a massive sell-off of US Dollars by countries the world over, in favor of the **Euro**, which would **become the new Base-line world currency**. As of Christmas 2006, China is holding 6.8 Trillion US Dollars in their reserves. How about Oil at \$ 600 a barrel, and none for sale for dollars? If Israel bombs Iran’s nuclear facilities with their own atomic weapons, all the Arab countries would just stop selling the US oil, at any price. Many of us were adults in 1973, when the fake oil supply crisis caused a **great shortage** of gasoline. Every oil and refinery worker in America knew the deal was a fraud, because every tank which could hold oil or gasoline in the country was full to the brim. The big oil companies got us to accept a 50 % price increase, if we could just drive our cars. It’s happening again now, engineered to progress in stages, so we accept it.

The United States of America was founded as a **Constitutional Republic**. The new Order designation of “ Democracy “ is a subterfuge for Slavery by the Jew owners. The

Jews constitute only 1 % of the world population, yet have achieved 78 % control of all the world's assets. The US Military uses **force** to maintain this control. NATO is also controlled by this Jew banking cartel, and supplements the US Military with “ Police Actions and War Actions “ to maintain control of the world for the Jew Trillionaires.

This Mega Jew Trillionaire Banking Cartel is the **hidden World Government**, which is fast moving to make tighter control, and establish their New **One World Order**, with total control over every living thing, and dissolve **all** the existing National Governments.

Even America is only the stroke of a Pen from total takeover by the New One World Order. **REX 84** is the prime plan for Military takeover, and subordinate plan **Cable Splicer**, administered by **FEMA** will rid the new OWO of the US Congress, Supreme Court, most Federal judges, States, State governments and subdivisions thereof, then the supplemental plan **Garden Plot**, administered by Homeland Security, will take over and control all media ( even the Internet ), transportation, factories, farms, aircraft, banks, and assets in general, and **proceed to use force and death camps** to remove all obstacles from their total takeover of the World. ### **Additional trips to the Same Well**

No regular person has any idea how the whole Banking and Tax Collection Fraud works. So pervasive is their control, that they are free to go back to the public well as many times as they wish. The Federal Reserve Banks sell US Government securities to “ Investors “, borrowing the money for the US Government, and issue Federal Reserve Notes ( costing 2.3 cents printed and delivered by the US Treasury Department ) into the Money Supply ( loan it out to Individual Banks at prime ) to control the economy. The FED collects a broker fee for handling the transactions, and gets to keep the interest paid to them for the Loans to the Individual Banks. US Citizens still owe the money to the Fed, which collects its interest in **Gold** ( the Fed will not accept Federal Reserve Notes as debt repayment ). There is no chance in hell of ever repaying the principal of the Debt, as it would take the entire National Product for 14 years, providing no new debts were added. Then the big Dip comes: **The same Jews** own all the “ Private Banks “. The Fed

Loans out the People's Money ( already borrowed, where every dollar loses 3.4 % when loaned ) at Prime, to these " Private Banks ". The Banks only have to keep 10 % on hand in cash receipts to stay solvent, so they are allowed to " Loan Out " \$ 9 for every \$ 1 they get from the Fed, which they earn additional interest on. These banks never actually put **up any of their own money**, just use " borrowed money " that actually belongs to the **People**. Cleverly, things were set up where the Fed Owners are never identified. So when the Federal Reserve Bank loans the Jews at Chase Bank \$ 4 Billion, no one knows that it is **an inside job to the same Mega Jews who own the Fed**. So since inception, the Federal Reserve banks have stolen \$ 47 Trillion in direct interest paid to it by the Government, \$ 7.6 Trillion in additional handling fees for Securities sales, and now own **all the Gold and Title to All of America**. The Income Tax in it's entirety goes to the IRS for fees, and directly **into the Fed accounts** to repay the interest on the massive debt. There is **no Statute Law** which requires any Individual Person to pay a **Tax on Income**. The whole deal is a **fraud** from the beginning, put in place by a willing bureaucracy to feed itself, stay in power, and keep the highly profitable wars going. The FDIC and FSLIC are **not insurance**. The contract actually sells the bank to the Fed ( a partnership), and can be activated any time, with the FED bank able to take over.

One wonders, if the **Federal Judges** who screw the citizens all the time with Illegal Trials, based on Laws which do not exist, in Courts with no subject matter jurisdiction, would continue to proceed with these actions if they knew **that all but 21 of them** are on the Red List or the Blue List of operation Cable Splicer for roundup and execution in the Death Camps within 6 weeks of Martial Law declaration. Would the State Governors, Attorney Generals, and Legislatures keep submitting to the Federal Government dictates and illegal laws if they understood that **ALL of them** are on either the Red List or the Blue List for extermination. Would the people of Indiana sit still for the new Auschwitz camp being finished and ready to exterminate millions being located in an Indianapolis suburb? Would the people of Texas put up with 6 death camps to handle 22,000 people each being already activated and ready for use? Would the Big Media, newspaper and TV networks continue to play dumb about what is transpiring if they really understood that almost all the faggot Jews that dominate their empire operations are also on the Red List and Blue Lists. Would Congress look the other way and continue to screw the people with an Illegal Income Tax, and let U.S. Federal Courts with no Subject Matter Jurisdiction put citizens in prison for violating non-existent laws if they knew that **all but 5** of them are on the Cable Splicer Blue List for extermination in the Camps? 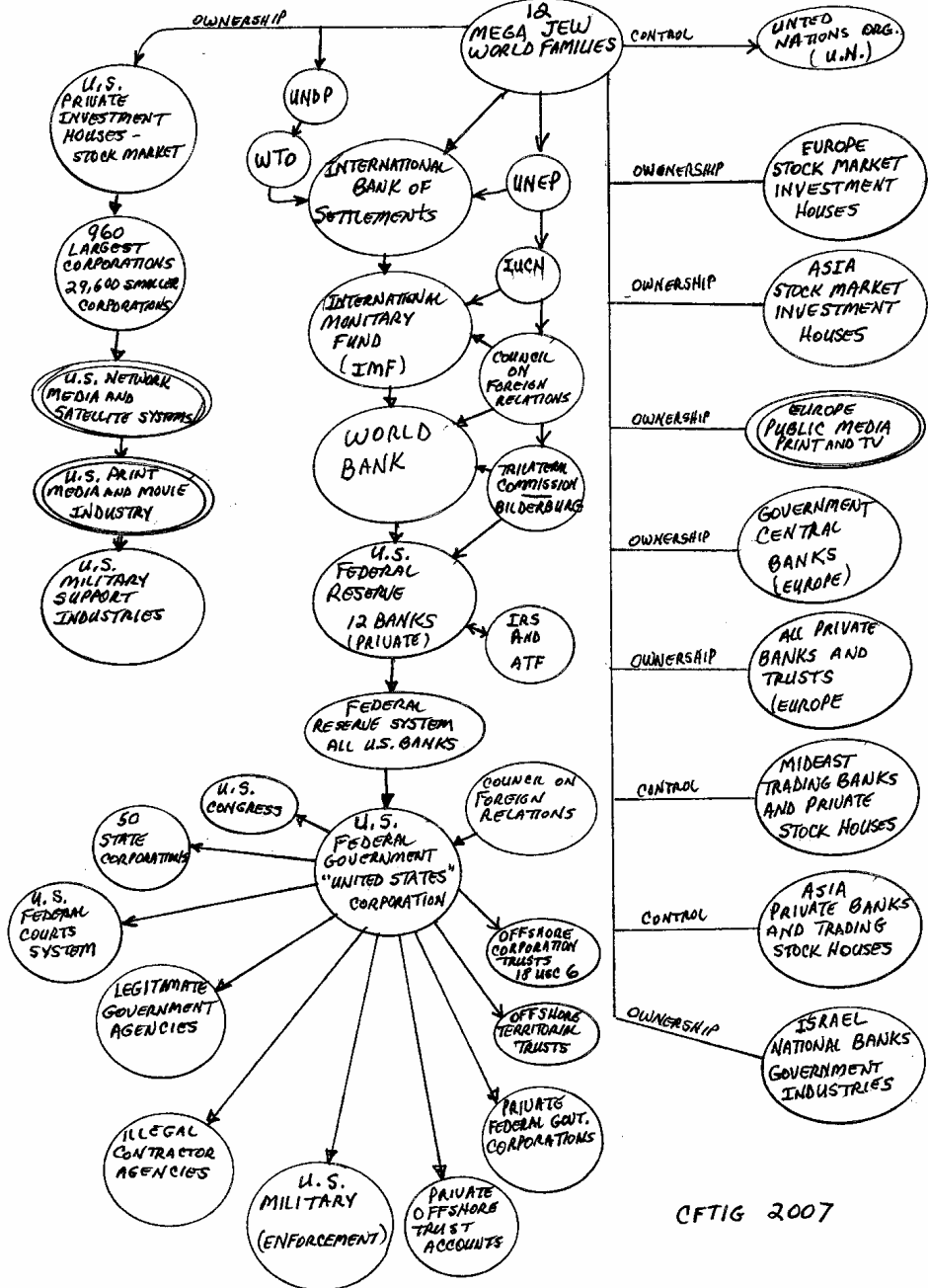
