

THE WORLD EXISTING FEUDAL SYSTEM IN YEAR 2009

Every country has been forced to adopt the Old Roman Law , Law of Contracts Known as the Universal Commercial Code, or Law of the Sea, which is Private Law, and each subservient State under each Sovereign government has been forced to adopt within it's Laws an Identical Form of Commercial Code, for business to be transacted with other Governments, their Bankers, and Individual State formed corporations and trusts. No government has authority over Natural Organic Human Beings. Lies to trick the human beings into acceptance, and pure brute force are used by the State to enforce it's will on the populace.

This system has been in place for more than 2 thousand years. It has been refined in secret, continuously through out all this time, each step drawing the organic humans into the web of lies and acceptance, and dominated servitude.

The organic humans in a continent called America tried to break out of this domination, and form their own free State, with all power in the hands and hearts of the organic humans. It has taken the time from 1775 to 2009 for the despotic money/ banking/ false church interests to eliminate this concept idea. Definitions:

Vatican: A Sovereign City-State, with authority given from God, which can issue documents of land grants and limited Sovereignty, create Corporate Persons, and transact business. It is headed by a King (Pope) who gets authority straight from God. The King is elected by the membership of Cardinals, who are appointed by the King (Pope). Not a part of Italy. Not a member of the European Union. Estimated world-wide property holdings of about \$ 700 Trillion, annual Tax-free income \$ 6 Trillion, stocks and cash holdings are hidden through investment Trusts (probably \$ 122 Trillion), most in Gold.

King: A Monarch, or King, granted (by the Vatican) limited Sovereignty, title to lands named, and control over the lands given, and the humans who are subordinate owned creatures to the Sovereign. Unlimited rights to Contracts, commissions, letters of marque.

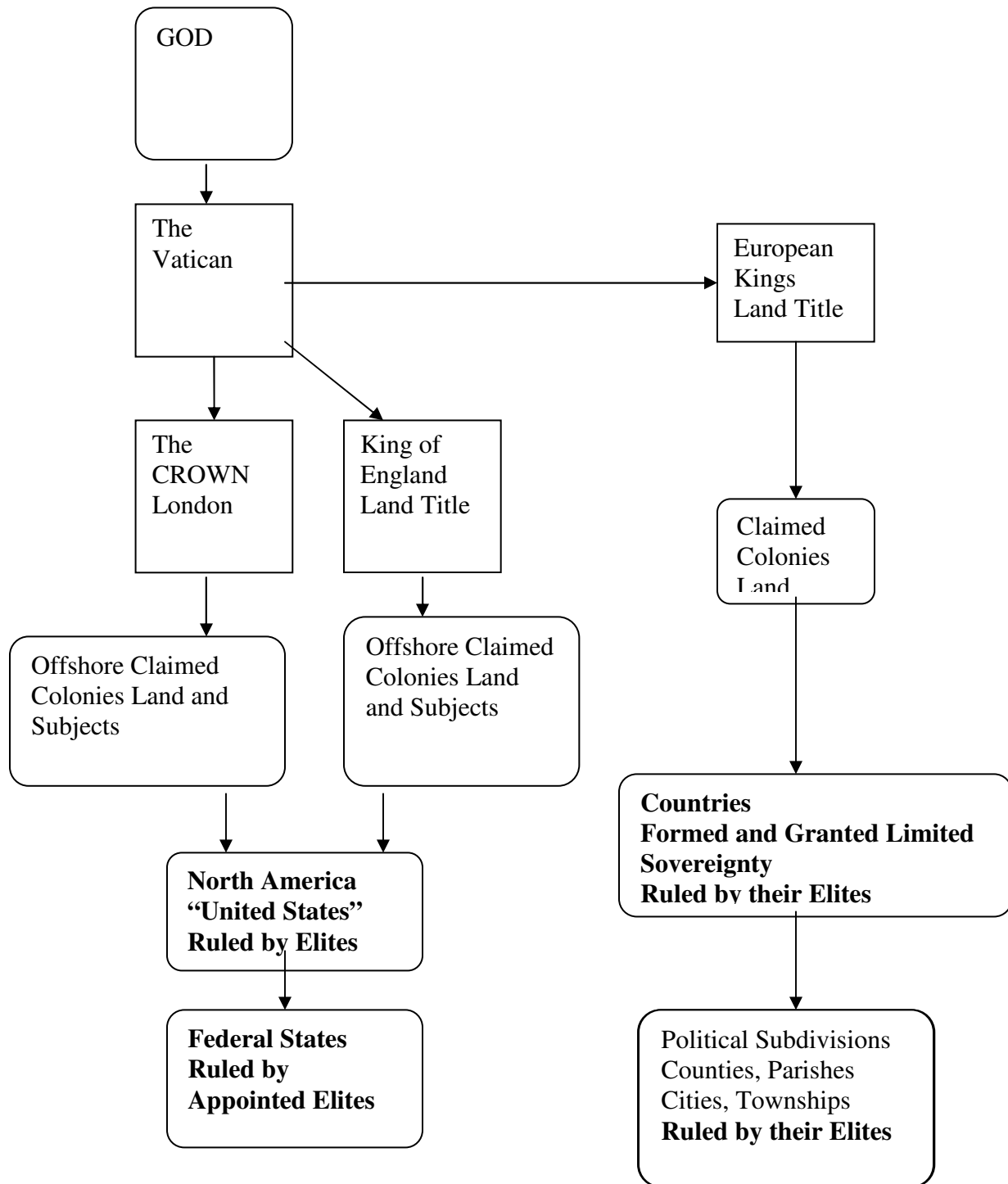
The CROWN: A Sovereign city-state (City of London) granted authority from the Vatican, to charter corporate persons, grant letters of marque to claim property for themselves or other Sovereign entities, and conduct all business as a Sovereign entity. It is separate from England, and England's King. It is the Banking capital of the World.

State: A defined Land and Political subdivision granted under authority of a Sovereign, with limited Sovereignty granted. Authority is defined, and powers granted by the Sovereign Entity, and carried out by subordinate entities created by the State administration. Terms are defined, and applicable rules are created to control and govern the created Persons (Corporate entities). The State has no authority over the organic humans, only the state created corporate " Persons ". Unlimited rights to Contracts, and Police authority.

Person: An entity, created by the State, with an Identical Name as an organic human being, which is granted rights and authority to do business. It is also defined as a corporation, limited partnership, general partnership, trust, and business entity. It is presumed that the organic human being of the identical name as the corporate person is the trustee and beneficiary responsible for administration of the affairs of the trust corporation. All liabilities, responsibilities, taxes and penalties are accrued by the corporate person, and the State Has the job of keeping the organic human ignorant of the truth, and forcing his acceptance of his role in State mandates against the corporation/ trust. Marriage is a partnership, with rights and responsibilities granted by the state, creating a new " Person ". An organic human being is not a " Person " in the federal Statutes, as they were created by God, and the State has no authority over them. These trust corporations are formed by a State Agency with the filing of a Birth Certificate document at the birth of a new organic human " subject " to the Sovereign.

The State agency forwards the birth information to the Federal agency Census Bureau, which retains the record and makes a duplicate Federal " Person " record, with your " Trust " of the same name, spelled with ALL CAPITAL LETTERS officially now domiciled in the " United States " District of Columbia. The business entity is therefore a resident and subject to the Laws, Rules, and Contracts of the " United States ".

THE FEUDAL SYSTEM AS IT STANDS TODAY, AND HAS BEEN



Hidden Lies: All organic humans in America, and all the other countries of the World are kept completely ignorant of the Feudal System in place.
